OUR PLACE-BASED, EXPERIENTIAL LEARNING PROGRAMS FOR PUGET SOUND AREA SCHOOLS ARE OFFERED ON OUR BAINBRIDGE ISLAND, WASHINGTON CAMPUS, AT THE BRIGHTWATER WASTEWATER TREATMENT PLANT IN WOODINVILLE, WASHINGTON, AND IN SEATTLE SCHOOLS AND COMMUNITIES. BECAUSE OF COVID RESTRICTIONS, WE WERE UNABLE TO OFFER ANY SCHOOL OVERNIGHT PROGRAMS FOR SEVERAL MONTHS DURING 2021-22 AND BRIGHTWATER PROGRAMS WERE ONLY DELIVERED VIRTUALLY.
